

## DEBT RECOVERY SEAL ORDER FORM SPECIAL OFFER

I oblige to timely payment for using the debt recovery seal according to the invoices issued by Lender and to using the debt recovery seal pursuant to its purpose and according to regulations with in force at present.

I understand and accept the following conditions:

- debt recovery seal of EuroWindykacja is owned by EW COLLECTIONS Sp. z o.o.;
- in case of damage the seal, the Lender replace this seal for undamaged one after the previous receipt of the damaged piece;
- there is no allowance to share the debt recovery seal of EuroWindykacja to other parties without written permission of the Lender;
- by ordering the debt recovery seal of EuroWindykacja I am allowed to use it for the period of 12 months;
- each party shall possess a right to terminate this agreement provided that the other party is informed in written form not later than three months prior.

With this order form I am allowed to have 10% discount for the debt collections services of the Lender within EuroWindykacja. I entitle the Lender to issue invoices for using the debt recovery seal.

I authorize the Lender to issue invoices for using the debt recovery seal without receiver's signature until further notice.

This agreement is automatically prolonged for another 12 months unless the written notice of termination is given not later than 30 days before its termination.
